Annual Report to the Members

Coweta-Fayette EMC is committed to providing you, our member-owners, with reliable electric service at a reasonable cost. This promise dates back to 1945, and it remains as strong today as it has been for decades. As we prepare for our 69th Annual Meeting and Member Appreciation Day Oct. 8, this is a great time to reflect upon the previous year and offer a preview into future ways the co-op will continue meeting your expectations.

In 2016, the longest active electric co-op director in Georgia–Kenneth Spaller–retired from our board after 51 years of service. He provided tremendous leadership during his tenure, and his wisdom will be sorely missed.

Fayette Co.'s Daniel C. Langford, Jr. was appointed to fill Kenneth's unexpired term. He is the current mayor of Brooks and an active member of his community. Although Daniel has big shoes to fill, he is capable and a considerable asset to our board.

Much of the past year was dedicated to planning. Not only do we want to ensure power flows when you flip the switch, we also seek the same results for future members as we continue to grow. To that end, we completed a construction work plan to carry us into 2018; this prospectus provides for new electric services/system improvements to meet growing demand, as well as distribution automation solutions to improve reliability.

Additionally, we renegotiated our wholesale power agreement with Southern Power, a subsidiary of Southern Company. This arrangement will meet our supply needs through 2027 and save member-owners \$18 million over the next 10 years. Southern Power will fill our capacity and energy needs in two ways: using existing generation resources that we own through Oglethorpe Power and Green Power EMC; and providing additional capacity and energy as required to serve our future growth.

Our two wholly-owned subsidiaries, True Natural Gas and Relyco Resources, continue to prosper, a fact that benefits you by improving the co-op's equity position and retail rates. True is still seeing exceptional growth, with rates that are consistently among the lowest in the state. Relyco maintains its record of reliable residential/commercial security services and home automation solutions, while also providing energy efficiency improvements as a member money-saving program. EMC directors' commitment to you goes beyond the board room. In 2016, three of these leaders received the "Director Gold" certification through NRECA, a designation recognizing directors who have earned Credentialed Cooperative Director and Board Leadership certificates and commending their commitment to continuing education. These endeavors give directors the knowledge to make decisions beneficial to our members.

Looking ahead, we must continue watching issues that may increase purchased power costs. During an en banc session of the D.C. Circuit Court of Appeals later this month, judges will hear arguments regarding the Clean Power Plan. This proposal requires a nationwide reduction in power plant carbon emissions of 32 percent below 2005 levels, a proposition with a significant cost impact. With prior mercury and air toxin regulations, Georgia's carbon footprint was already reduced 30 percent. While we care about the environment, we also care about protecting member rates. Out of every dollar spent today, nearly 70 cents is for purchased power.

In complicated times, innovation thrives. Your EMC has always been leading-edge when it comes to meeting members' needs. We are a founding member of Green Power EMC, through which we have added more renewables, like solar, low-impact hydro and biomass (landfill gas/wood by-products). By year's end, we will add another 10 MW of solar generation.

While this is exciting news, we must also maintain a diverse power portfolio providing both reliability and affordability. Recently, much coal generation has been replaced by natural gas resources. This has been reflected in lower energy costs, and we have happily passed these savings to you. We know, however, that natural gas prices are volatile and can increase for many reasons, like hurricanes. To keep a varied portfolio and meet ever-increasing regulatory demands, we elected to participate in ownership of two new Plant Vogtle nuclear units. Although they will not produce energy until 2019/2020, it is this foresight that will give members clean, efficient power for years to come.

Coweta-Fayette EMC directors and employees understand that you, our members, are the reason our jobs exist. With this in mind, we will continue working tirelessly to provide reliable electricity at a reasonable cost. We look forward to serving you in the future and hope to see you October 8! Sincerely,




